## WHAT'S BEEN HAPPENING?

The current Board of Education has passed a policy that is in direct violation of New Jersey's Law Against Discrimination, and the State's Attorney General sued Hanover Township for the policy. The BOE was given a chance by the judge to find a compromise or solution but didn't. The judge ruled against the BOE. The BOE now plans to continue the fight in court at taxpayers' expense.

Your tax dollars have been spent to cover the Board's legal fees, which have **increased 1000%** vs last year.<sup>1</sup>

This spending will not stop until there are new voices who will fight for a solution.
